We will not ship firearms to a third party to be modified or changed in any way from manufactured specifications. The firearm you purchase must be compliant AS IS from the manufacturer before we will ship.

Information regarding State and local restrictions, laws and ordinances presented on this page is accurate to the best of our knowledge at the present time. Laws and ordinances for firearms, ammunition, and certain other items are however, subject to change, without notice to us.

Rifles

The following are prohibited:

- ✘ Rifles with a capacity over 10 rounds.
- ✘ Semi-automatic rifles with a detachable magazine and have any **TWO** of the following features:
 1. Folding stock (Not including telescoping [collapsible] stock)
 2. Grenade launcher or flare launcher
 3. Flash suppressor
- ✘ Semi-automatic centerfire rifles that have an overall length of less than 29 inches.
- ✓ Stripped lower receivers permitted. Complete lower receivers without prohibited characteristics (above) are permitted.

“The above restrictions do not apply to rimfire rifles with non-detachable magazines.”
“AR rifles not otherwise prohibited (see above) must possess a heavy-barrel contour (no cutouts).”

AR-10 type rifles are not regulated and should be transferable. AR-15 rifles featuring a heavy barrel contour are not regulated and should be transferable.

Rapid-fire Trigger Activators: A person is prohibited from transporting a rapid-fire trigger activator into the State or manufacturing, possessing, selling, offering to sell, transferring, purchasing, or receiving a rapid-fire trigger activator, defined as any device, including removable manual or power-driven activating device, constructed so that, when installed in or attached to a firearm, the rate at which the trigger is activated increases, or the rate-of-fire increases. This prohibition includes binary trigger systems. However, a rapid-fire trigger activator does not include a semi-automatic replacement trigger that improves the performance and functionality over the stock trigger (SB 707).

Shotguns

The following are prohibited:

- ✘ Shotguns with a capacity over 10 rounds in a detachable magazine.
- ✘ Semi-automatic shotgun that has a folding stock (Not including telescoping [collapsible] stock)
- ✘ Any shotgun with a revolving cylinder.

The following are permitted:

- ✔ Kel-Tec KSG, DP-12, and similar pump shotguns with fixed tubular magazines, which may contain 10 rounds or more, are permitted.

Please Note:

Maryland defines "regulated firearms" to include a "handgun" which is defined in SS. 5-101(n)(1) to mean "a firearm with a barrel less than 16 inches in length." This will include certain types of firearms that expel a shotgun shell, but are not ATF long guns. Therefore any firearm with a barrel length less than 16" in Maryland and defined as a "handgun" must appear on the Maryland Handgun Roster before transfer is permitted.

Handguns

The following are prohibited:

- ✘ No handguns with a capacity over 10 rounds.

Must be on [Maryland Handgun Roster](#) to be considered compliant.

Accessories / Ammunition

We do not ship magazine extenders or extensions.

The following are prohibited:

- ✘ Magazines exceeding 10 rounds.
- ✘ Stun guns, TASERs, and Defense Spray sales are not permitted in the City of Baltimore, Baltimore County, or Howard County.
- ✘ No sales of Tannerite compounds or targets, or similar exploding target materials.

Rapid-fire Trigger Activators: A person is prohibited from transporting a rapid-fire trigger activator into the State or manufacturing, possessing, selling, offering to sell, transferring, purchasing, or receiving a rapid-fire trigger activator, defined as any device, including removable manual or power-driven activating device, constructed so that, when installed in or attached to a firearm, the rate at which the trigger is activated increases, or the rate-of-fire increases. This prohibition includes bump stock, trigger crank, hellfire trigger, binary trigger system, burst trigger system, or a copy or a similar device, regardless of the producer or manufacturer. However, a rapid-fire trigger activator does not include a semi-automatic replacement trigger that improves the performance and functionality over the stock trigger (SB 707).
